

## **Mercedes Homes' Bar Date FAQs**

As part of the reorganization process, Mercedes Homes submitted a schedule of known creditors to the courts for review. That schedule included the amounts that Mercedes Homes believes is due to our creditors. The information below details how you can access that schedule to see if your name and the amount that you believe you are owed appears.

**Q: How can I access the schedule of known creditors?**

A: The schedule is available at the Clerk of the Court, United States Bankruptcy Court, Southern District of Florida, West Palm Beach Division, Flagler Waterview Building, 1515 N. Flagler Drive, Room 801, West Palm Beach, Florida, 33401, during regular business hours. The schedule may also be viewed and downloaded free of charge at [www.kccllc.net/MercedesHomes](http://www.kccllc.net/MercedesHomes).

**Q: I reviewed the schedule and agree with the information that was provided on the schedule. Do I need to file a claim?**

A: If your name appeared on the schedule and if you agree with the claim amount, you do not need to do anything further, and your claim will be processed under the terms of the plan.

**Q: I reviewed the schedule and do not agree with the information that was provided on the schedule. Do I need to file a claim?**

A: If you do not appear on the schedule (and believe that you should), or if you disagree with the listed claim amount, then you must formally submit a claim.

**Q: What information should I include in my claim?**

A: You may click on the link [here](#) in order to download the official Proof of Claim submittal. This form will ask for your name, your contact information, the amount of your claim and your basis for making a claim. [This form is required for submission of your claim.](#)

**Q: What is the deadline for filing my claim?**

A: You must file your claim by 5:00 p.m., Pacific Time, June 29, 2009. Your completed claim must be filed with Kurtzman Carson Consultants LLC, either in person or by mail. No faxed or e-mailed claims will be accepted.

**Q: Where should I mail or deliver my claim?**

**Q: How can I receive confirmation from Kurtzman Carson Consultants that my claim has been received?**

**A:** If you wish to receive an acknowledgement of receipt of your claim, you must provide Kurtzman Carson Consultants with an additional copy of the proof of claim with a self-addressed, postage-paid return envelope.

**Q: Should I also send a copy of my claim to Mercedes Homes or its legal counsel?**

**A:** No. All claims should be sent directly to Kurtzman Carson Consultants for review and processing. Also, please note that claims sent to Mercedes Homes will not be forwarded to Kurtzman Carson Consultants.

**Q: I'm not sure that the Debtor listed in my claim is Mercedes Homes, specifically. Are there any other subsidiaries of Mercedes Homes that also apply in this case?**

**A:** Yes, the Debtor subsidiaries of Mercedes Homes include Space Coast Truss, Inc. ("Space Coast Truss"); Mercedes Homes of Texas Holding Corp. ("MH Texas"); Suntime Office Complex, LLC ("Suntime"); Engineering and Drafting Services, Inc. ("Engineering Services"); Mercedes Homes of the Carolinas, Inc. dba Mercedes Homes ("MH Carolinas"); Solid Wall Systems, Inc.; MHI Holding Company, LLC ("MHI Holding"); Mercedes Homes of Texas, Ltd. ("MH Texas"); MHI Building Products, L.P. ("MHI Building"); and Dairy Towns Community Developers, Inc. ("Dairy Towns").

**Q: After I submit my claim, what should I do next?**

**A:** You are responsible for pursuing your own claim. You should periodically check the [web site](#) for information on the progress of your claim, and you might also want to consider seeking legal advice about pursuing your claim. Mercedes Homes is not responsible for providing any information or pursuing your claims.

**Q: What happens if I fail to submit my claim by the designated deadline?**

**A:** According to law, any holder of a claim that fails to file a proof of claim on or before June 29, 2009, is forever barred, estopped and enjoined from asserting any such claim against Mercedes Homes. You will also be barred from voting on or receiving any distribution under any plan or plans of reorganization for the Debtors (Mercedes Homes) on account of such claim. In addition, you will not be entitled to receive any further notices or mailings in these proceedings.
